II. SECTION TWO: **READ CAREFULLY BEFORE SIGNING**In consideration of being permitted to join United Racing Club and being permitted to participate in or be a spectator at United Racing Club membership events during 2024, I hereby:

1. Release, waive, discharge, and promise not to sue United Racing Club, any of its officials, any of its members, any of its sponsors, or car owners, drivers, pit crews, for personal injury or property damage which I sustain during 2024 arising out of an United Racing Club event, whether my loss is caused by the negligence of United Racing Club or its members. This does not waive rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. Agree to indemnify and hold harmless United Racing Club, its officials and members for any loss, liability, damage, or cost which may incur due to my presence at a United Racing Club event, whether I am competing, officiating, or observing a United Racing Club event.
3. Assume the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risks can cause.
4. Reserve to United Racing Club and its members and officials, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee-shirts, and other such novelty concession items, written articles about me, photos and drawings of my likeness or of my racecar. This does not prohibit me from producing promotional products, nor does this allow URC to take any proceeds from material produced by me, unless marketed by United Racing Club.
5. I understand that I will be entitled to benefit of the Competitor Accident Insurance policy procured by the Speedway for accidental injuries or death. The coverage of said policy shall constitute the limit of liability of the Speedway for such injuries occurred to me in the event, provided proper notification of such occurrence is filed with the Speedway. It is understood that the policy held by the track is secondary insurance. The United Racing Club license fee does not include any insurance policy.
6. Governing Law. In the event of a dispute arising under this Agreement, it is agreed between the parties that the law of the State of Pennsylvania, Philadelphia County will govern the interpretation, validity and effect of this agreement without regard the place of execution or place of performance there of.
7. I certify that I am an independent contractor, assuming all responsibility for monies received as a result of my activities with United Racing Club including income taxes. I hereby certify that any license granted hereunder is granted for the sole purpose of enabling me to participate in the furtherance of any enterprise to wit, a race, or other motorsports related activity. My presence in, about or enroute to or out of any premises where United Racing Club sanctioned events are presented in furtherance of that United Racing Club event.
8. By signing below, agree to follow all the rules and regulations and responsibilities as printed in the 2024 United Racing Club rules. I hereby release the officials of United Racing Club from damages resulting from their decisions and/or interpretations of rules.
9. Have read the forgoing and understand its contents and agree that if any of the paragraphs or provisions of this contract are deemed illegal, the rest of the document shall stand in full force and effect.
